SUMMARY

In accordance with Section 961 of Title 49 of the Louisiana Revised Statutes, there is hereby submitted a fiscal and economic impact statement on the rule proposed for adoption, repeal or amendment. The proposed rule change will give clearer instructions for the annual renewal process and continuing education requirements to all licensees and certificate holders.


