PRODUCT RECALLS

PRODUCT/FIRM:

Basket with Balls by Monti Kids

DESCRIPTION:

This recall involves Basket of Balls that contains a blue crochet ball included in the Monti Kids Tummy-Time, 4-6 M Play and Early Gross Motor subscription boxes. The Basket with Balls has a blue crochet ball, a wooden ball, and a red rubber ball that measure about 3.5 inches by 3.5 inches by 4 inches. MontiKids is printed on a label sewn inside of the basket.

REMEDY:

Consumers should immediately stop using the recalled toys and contact Monti Kids for instructions on receiving a refund of \$12. Consumers should show proof of destroying the recalled ball by cutting the blue crochet ball in half and then throwing the recalled ball in the garbage. Once they have cut the ball in half, they should send a photo of destruction to customer@montikids.com. Consumers should state in the email that the recalled ball has been removed from use and indicate their refund preference either back to the credit card used for payment or a mailed check. Monti Kids is contacting all known purchasers.

DESCRIPTION:

This recall involves the IKEA BLÅVINGAD fishing game. The article name “BLÅVINGAD”, article number “10539622”, supplier number “21576”, and “Made in China” are located on the back of the blue box. The ocean-themed fishing game consists of two wooden fishing lines with string and magnets to attract wooden play pieces with metal rivets. The game consists of 11 pieces and a die.

REMEDY:

Consumers should immediately stop using the recalled game and contact IKEA for a full refund.

Children's Robes by Goumi

**DESCRIPTION:**

This recall involves children's robes. The robes consist of 100% cotton, have two functional front pockets and an attached belt. The robes were gifted in children's sizes 0 through 6T and in natural and alabaster colors. The sewn-in neck label displays the brand "goumikids" and the robe's size. The inside tag has the material content, washing instructions and "Made in China, designed in Portland, OR."

REMEDY:

Consumers should immediately take the recalled robes away from children, stop using them, and contact Goumi. Consumers should destroy the robes by cutting them both vertically and horizontally and disposing of them in accordance with local/state recycling laws. Consumers should send an image of the destroyed recalled robes to Goumi by email at productrecall@goumikids.com. Upon receipt of the image, consumers will be issued instructions on how to receive a \$48 store credit towards a replacement product. Goumi is directly contacting known consumers directly.

**DESCRIPTION:**

This recall involves Arshiner-branded children's long-sleeved nightgowns. The 94% polyester 6% spandex nightgowns have a lace trimmed neck collar, lace hemline and cinched elastic at the wrists. They were sold in sizes 4 through 13 years and in 10 prints: "Cat Meow" print in blue, "Sleeping Cat in Cup" print in purple, "Polka Dots Cat" print in orange, "Reindeer Cat and Snowflakes" print in red, "Panda Dream Big" print in blue, "Hamburger and Fries Best Friends" print in pink, "Fairy" print in purple, "Green and Navy Plaid" print, "Cat Catwalk Ready" print in navy, and "Sloth Just Do Nothing" print in pink. "Arshiner," "Made In China" and the size are printed on the nightgown's neck label.

REMEDY:

Consumers should immediately take the recalled nightgowns away from children, stop using them, and contact Arshiner for a full refund. Consumers should destroy the nightgowns by cutting them both vertically and horizontally and disposing of them in accordance with local/state recycling laws. Consumers should send an image of the destroyed recalled nightgowns to Arshiner by email at arshiner.recall@gmail.com. Upon receipt of the photo, consumers will be issued a full refund of the purchase price. Arshiner and Amazon are contacting all known purchasers directly.

This recall involves FunnyPaja's children's 100% polyester fleece plush hooded bathrobes. The bathrobes have an adjustable and attached waist belt that is sewn into the side seams and two functional front pockets. The bathrobes were sold in sizes 2T through 14 Years in 17 different prints and patterns: Pink Dinosaur, Wine Red, Navy, Cool Car, Dino Fossil, Green Dinosaur, Blue Shark, Blue Black Plaid, Dinosaur Home, Cool Spaceman, Green Crocodile, Grey Excavator, Black White Plaid, Blue Dinosaur, Cool Buffalo Plaid, Royal Blue, and Navy Bear. "Made in China," the Chinese size designation and the washing instructions are printed on the neck label.

REMEDY:

Consumers should immediately take the recalled bathrobes away from children, stop using them, and contact FunnyPaja for a full refund. Consumers should destroy the bathrobes by cutting them both vertically and horizontally and disposing of them in accordance with local/state recycling laws. They were sold in sizes 1 year through size 13 years and in the following colors: white, gray, cream, blue, navy, purple, pink, and orange. The sewn-in neck label displays "Made in Turkey", "100% Cotton" and washing instructions.

REMEDY:

Consumers should immediately take the recalled robes away from children, stop using them, and contact Bagno Milano for a full refund. Consumers who purchased the robes will be asked to destroy the robes by cutting them both vertically and horizontally and disposing of them in accordance with local/state recycling laws. REMEDY:

Consumers should immediately take the recalled robes away from children, stop using them, and contact The Company Store for a full refund. Consumers should destroy the robes by cutting them both vertically and horizontally and dispose of them in accordance with local/state recycling laws. **DESCRIPTION:**

This recall involves CultureFly's L.O.L. Surprise! Trick or Treat-themed boxes sold with metal doll pins. The purple boxes have an image of three dolls, spiderwebs, skulls, and bats; and the phrases L.O.L. Surprise! and Trick or Treat are printed on top. The metal doll pin has blue, pink, and purple hair in pigtails, blue eyes, pink shoes, and bra and underwear. They include magnetic, cutout clothes to dress the doll.

REMEDY:

Consumers should immediately take the recalled metal doll pins away from children, stop using them, and contact CultureFly for a \$10 refund. Consumers will receive an e-mail with instructions to return or dispose of the recalled metal doll pins in accordance with local state laws. Consumers will be contacted directly by CultureFly.



The tabletop activities include a grooved track for vehicle play, a bell arch, a bead and wire maze, a shape sorter, gear activity, and stacking activity. The model number J04402 or J04411 can be found on a label on the underside of the activity table.

REMEDY:

Consumers should immediately stop using the recalled activity tables and contact Juratoys for a free repair kit.

The Angelica Nightdresses come in Picnic check flannel, Rose bud floral, Wildflower floral, Cove blue check flannel, Ruby floral, Worker stripe in brushed cotton, and White seersucker cotton prints.

The Traditional Pajamas come in Picnic check flannel, Cove blue check flannel, and Worker stripe in brushed cotton prints. The Pippa Pajamas come in Picnic check flannel, Cove blue check flannel, Worker stripe, and Ruby Floral in brushed cotton prints. The 100% cotton pajamas were sold in sizes for ages 2 to 3 years to 8 to 9 years. The size and “Little Cotton Clothes” are printed on the neck label. The side seam label has the fiber content and washing instructions.

REMEDY:

Consumers should immediately take the recalled pajamas and nightdresses away from children, stop using them, and contact Little Cotton Clothes for instructions on how to dispose of the pajamas for a full refund. Little Cotton Clothes is directly contacting all known purchasers.

This recall involves Deux Par Deux organic cotton one-piece and two-piece printed pajama sets. The children’s sleepwear are made of 100% organic cotton and were sold in sizes 9 months to 12 years. The one-piece pajama sets were sold in rose, bears and trees, and bear Christmas prints. The two-piece printed pajama sets include a long sleeve top and bottom. The designs are horses, deer and trees, bears and trees, Unicorns and trees, automobile, forest animal, roses, and cat prints. The neck label states “Deux Par Deux” and the garment size. The side seam label has the fiber content and washing instructions, date of production, city of production, “Groupe Minimome Inc” and PO number.

REMEDY:

Consumers should immediately take the recalled pajamas away from children, stop using them, and contact Deux Par Deux for instructions on how to dispose of the pajamas for a full refund. Deux Par Deux is directly contacting all known purchasers.

DESCRIPTION:

This recall involves Zooby video baby monitors for cars. The baby monitors are housed in a plush animal toy including a giraffe, dog, fox, rabbit, and panda. The recalled Zoobys have battery model number HJ554050 batch 2136. Unscrew the battery door with a small screwdriver from the bottom of the plush camera. The battery shows the markings 554050 which is the model number and 2136 which is the production batch number. The brand name Zooby is on the bottom front of the monitor.

REMEDY:

Consumers should immediately remove the battery from the plush camera and can continue using the zooby plush camera and monitor plugged in. Contact Infanttech for a free replacement battery. Infanttech is contacting all known purchasers.

Children's Multi-Purpose Helmets by Sound Around



DESCRIPTION:

This recall involves the Hurtle multi-purpose children's helmet. The helmets were sold in black, blue, pink, white, and red. The helmets have the word "Renegade" on the side in white or black lettering. The straps are black and the white warning label on the inside of the helmet states "Renegade" in black and orange lettering. The helmets are sized to fit head circumferences from about seven inches to about eight inches.

REMEDY:

Consumers should immediately stop using the recalled helmets and contact Sound Around to receive a full refund of the purchase price. To receive a refund consumers should destroy the helmet by cutting off the straps, upload photos of the helmet with the straps cut to the recall registration website

and then dispose of the recalled helmet. Consumers who received the unit as a free promotion should dispose of the unit so that children cannot use it.

DESCRIPTION:

This recall involves both full-size Robo Alive Junior Baby Shark Sing & Swim bath toys and Mini Baby Shark Swimming bath toys. The recalled full-size Baby Shark bath toys sing and swim when placed in water. They have a hard plastic top fin with three grooves on one side, measure about 7-inches from nose to tail and were sold in three colors: yellow, pink, and blue. They were sold individually and in packs of three. The recalled full-size bath toys have tracking label information on the bottom, including raised lettering that states model number "#25282" and a date code beginning with the letters "DG" followed by "YYYY/MM/DD" in the date range DG20190501 through DG20220619. Only full-size Baby Shark toys with a hard plastic top fin are included in this recall.

REMEDY:

Consumers should immediately stop using the recalled bath toys and contact Zuru for a full refund of \$14 for each full-size bath toy or \$6 for each mini-size bath toy, in the form of a prepaid virtual Mastercard. Consumers should disable the tail fin (by cutting it on the full-size bath toy or by bending it on the mini-size bath toy), mark the body of the shark bath toy with the word "recalled" and the unique code provided during registration for the recall, then upload a photo of the product, showing it is disabled and marked, at www.recallrtr.com/bathshark. Upon receipt of the photo, Zuru will issue a refund to purchasers.
