# PRODUCT RECALLS

PRODUCT/FIRM: LXDHSTRA Baby Loungers and Crib



Bumpers Recalled Due to Risk of Serious Injury or Death from Suffocation and Fall Hazards; Violates Federal Standard for Infant Sleep Products and Federal Crib Bumper Ban; Sold on Amazon

**DESCRIPTION:** This recall involves

LXDHSTRA-branded baby loungers. The recalled baby loungers include a foam sleeping pad and padded bumpers with a cloth cover. The baby loungers were sold in the following prints: tan star, big elephant, green elephant, gray feather and gray rainbow; and came with a red and black padded crib bumper that has letters "A" through "F" on one side and animal characters on the other **CONSUMER CONTACT**: LXDHSTRA by email

**REMEDY:** Consumers should immediately stop using the recalled baby loungers and crib bumpers and contact LXDHSTRA for a full refund. Consumers should remove the foam and pads from the baby lounger's cover and cut the cover, foam, pad, and crib bumper in half. PRODUCT/FIRM: YooxArmor Multi-Purpose Kids' Helmets Recalled Due to Risk of Serious Injury or Death from Head Injury; Violates Mandatory Standard for Bicycle

**DESCRIPTION**: This recall involves YooxArmor multi-purpose kids' helmets. The recalled helmets were sold in size small (S). The helmets were sold in pink with a unicorn, rainbow and star print with black padding, black straps, and a black and red buckle with a black chin pad. The helmets have a black and red plastic knob at the back of the helmet for adjusting the fitting. "YooxArmor" is printed on the back of the helmet.

REMEDY: Consumers should immediately stop using the recalled kids' helmets and contact YooxArmor for a full refund. Consumers should destroy the recalled helmet by cutting the straps off the helmet. Consumers can upload photos of the helmet with the straps cut off

**PRODUCT/FIRM:** Youbeien Crib Mobiles Recalled Due to Risk of Serious Injury or Death from Battery Ingestion; Violates the Mandatory Toy Standard for Batteries;

Sold on Amazon by GKKBSJ

**DESCRIPTION:** This recall involves Youbeienbranded crib mobiles. The crib mobile with timing function for music and lights comes in pink and

purple and has a plastic arm that attaches to the side of a crib, a music box and four arms with dangling plastic animal characters (penguin, pig, lion, unicorn, and others). The mobile measures about 17 inches wide by 20 inches high and comes with a remote to control music and rotation. The product packaging has the brand name "Youbeien" printed on the top left corner, "music rotating bed bell" printed on the front and back, and model "RT668-17" printed on a white label on the back. REMEDY: Consumers should immediately stop using the recalled toy and contact GKKBSJ for a refund. Consumers will be asked to throw away the product and send a photo of the disposed product

to <a href="mailto:gkkbsjtoys@outlook.com">gkkbsjtoys@outlook.com</a> to receive a full refund. If consumers wish to continue using the crib mobile, they can throw away only the remote and send a photo of the disposed remote to <a href="mailto:gkkbsjtoys@outlook.com">gkkbsjtoys@outlook.com</a> to receive a refund of \$8. The crib mobile is fully functional without the remote control via buttons on the unit.

**Note:** Button cell batteries are hazardous. Batteries should be disposed of or recycled by following local hazardous waste procedures.

**PRODUCT/FIRM**In My Jammers Recalls Button Flare Pajama Sets Due to Burn Hazard; Violates Mandatory Flammability Standards.

**DESCRIPTION:** This recall involves In My Jammers-branded children's button up flare sets. The recalled pajama sets consist of a 95% viscose and 5% spandex short-sleeved shirt with buttons and matching flared pants. The pajama sets were sold in the following patterns: bows, swans, cherry, croissant and coffee, kiss, and floral prints in sizes 2T through 6T, 7/8, and 9/10. "In My Jammers" and the size are printed on the

neck label of the pajama top.

**PRODUCT/FIRM:** Shierdu Children's Toys Recalled Due to Risk of Serious Injury or Death from Choking Hazard; Violates the Small Parts Ban; Sold on Amazon by Yiwu Shiyi Trading

**DESCRIPTION:** This recall involves Shierdu's children's wooden building block cactus toys. The toys consist of 28 pieces: a natural wood color base with holes and wooden, bulbous segments with pegs that are painted yellow, light green, dark green, blue, red and gray and attach to each other to form a cactus. "SHIERDU" and model number "SY-016" are printed on the label located on the product's packaging.

Imported by MTC Trading.

**DESCRIPTION:** This recall involves Party Favors lite-up torches and mini laser pointers. The affected models are:

- Model PF-1082: A single lite-up torch sold in white, blue or orange, measuring about 5 inches long and 2 inches wide.
- Model PF-1227: A two-pack of lite-up torches sold in orange and green, measuring about 4 inches long and an inch wide.
- Model PF-1153: A three-pack of lite-up torches sold in orange, blue and green, measuring about 3 inches long and an inch wide.
- Model PF-1084: Mini laser pointers sold in blue, green, red and silver, measuring about 3 inches long and an inch wide.

All products come with pre-installed button cell batteries. The model number can be found printed on the hang tag.

**REMEDY:** Consumers should immediately stop using the Lite-Up Torches and Mini Laser Pointers, take them away from children and place them where children cannot access them. Consumers may contact MTC Trading to request a full refund. **DESCRIPTION:** This recall involves three-tiered spiral children's tower toys.

The recalled toy has three levels and a basketball hoop with a character's face at the top. The toy measures about 10 inches high by 4 inches wide and came with three yellow balls.

Young Children; Violates Multiple Mandatory Standards **DESCRIPTION**: This recall involves the Firefly Safe & Green 32 oz. bottles. The fuel comes in a transparent bottle with a white cap and nozzle applicator. The fuel bears the "Firefly" brand, "Safe & Green" in large green font, followed by "The One Fuel." The label also states "Non-Toxic", "Readily Biodegradable", "Odorless", "Bright Flame" and "Certified Kosher" on the front of the bottle. The rear of the bottle contains hazard labeling and the firm's business address.

**REMEDY:** Consumers should immediately remove the nozzle applicator from the recalled Safe & Green 32 oz. Fuel bottle and reinstall the child-resistant closure that was included with the product's original packaging. If the child-resistant closure is not readily available, consumers should immediately secure the recalled Safe & Green 32 oz. fuel bottle out of the sight and reach of children. Consumers should contact Firefly Fuel for a free corrected label to put on the bottle and a free replacement child-resistant lid, if the original is missing.

**PRODUCT**/FIRM: La Ligne Recalls Enfant Bonne Nuit Pajamas Due to Burn Hazard; Violates Mandatory Flammability Standards.

**DESCRIPTION:** This recall involves La Ligne Enfant Bonne Nuit children's 100% cotton pajamas. The two-piece long sleeve pajama sets were sold in green

with light blue trim, pink with red trim, red with white trim, light blue with red trim, navy with white trim, and white with navy trim. There is a pocket on the left side of the top of the pajama sets. The pajamas were sold in sizes 2, 4, 6, 8 and 10. "La Ligne", "Mini" and the size are printed on the neck label. The words "Made in Peru" and "RN number 150209" are printed on the seam label.

**REMEDY:** Consumers should immediately take the recalled children's pajamas away from children, stop using them and contact La Ligne for a full refund. Consumers will be asked to destroy the garments by cutting them in half and disposing them. PRODUCT/FIRM: Séfralls Minoxidil Hair Generation Serum Recalled Due to Risk of Serious Injury or Death from Child Poisoning; Violates Mandatory Standard for Child Resistant Packaging; Manufactured by Guangzhou Ariel Biotech.

DESCRIPTION: This recall involves Séfralls Hair Generation Serum. The hair serum comes in an amber dropper bottle with a white and gold dropper and a white, black and gold label. "Séfralls" and "Minoxidil" are printed on the label located on the front of the bottle.

**REMEDY**: Consumers should immediately secure the recalled serum bottles out of sight and reach of children, and contact Guangzhou Ariel Biotech for instructions on destroying the recalled bottles and receiving a replacement. **DESCRIPTION:** This recall involves LeymanKids-branded children's two-piece pajama sets. The recalled pajama sets consist of a long-sleeved, button-up top and matching pants. The pajama sets were sold in white, pink, yellow, red, blue, beige and green, and feature cartoon patterns. The pajama sets were sold in children's sizes 24M (90), 3T (100), 4T (110), 5T (120) and 6T (130). The brand name and size are printed on the neck label of the pajama top.

**REMEDY:** Consumers should stop using the recalled pajamas immediately and contact AliExpress to receive a full refund. Consumers should destroy the pajamas by cutting them in half, then take a photo and dispose of them. Monica Vinader 14k Yellow Gold Mini Heart Chain Bracelets (SKU YG-BL-HART-NON), Necklaces (SKU YG-NK-HART-NON) and Stud Earrings (SKU YG-EA-HARS-NON). The recalled jewelry pieces are constructed of 14k yellow gold, contain mini heart pendants and were manufactured in October and November 2024. The chain bracelet measures about 15.3-19 cm, the necklace measures about 41-46 cm and the earrings each measure about .35 cm x 0.4 cm x 0.1 mm.

**REMEDY**: Consumers should immediately stop wearing the recalled jewelry, store the jewelry safely out of reach of children, and contact Monica Vinader for a replacement or refund. Consumers can return the jewelry items via prepaid shipping label and receive a replacement or a full refund to their original payment method or, if unavailable, by secure wire transfer. The toy measures about 13 inches high by 4 inches wide and comes with three yellow balls. "TEMI GO BASKETBALL" is printed on the front of the product packaging.

**DESCRIPTION:** This recall involves four different styles of Baby Loren Morning children's 100% cotton loungewear dresses. The loungewear was sold in floral tulips, princess and castle and unicorn and butterfly prints and in sizes 2T, 3T, 4T, 5Y and 6Y. The Baby Loren logo, the size, "October 2022" or "October 2023" and a batch number ending in 3465, 3585, 3599 or 3569 are printed on sewn-in neck labels.

**REMEDY:** Consumers should stop using the recalled dresses immediately and contact Baby Loren for information on how to return the recalled dresses free of cost for a full refund. Baby Loren is contacting all known purchasers directly.

**PRODUCT/FIRM:** Backyard Kids Recalls KidKraft Farm to Table Play Kitchens Due to Strangulation Hazard; One Death Reported

DESCRIPTION: Backyard Kids, LLC,

of Plano, Texas, is recalling about 192,000 KidKraft Farm to Table Model Play Kitchens, originally manufactured by KidKraft, Inc. Backyard Kids has voluntarily agreed to recall and provide free replacement hooks for all units, even though only about 400 of the 192,000 recalled units were sold to consumers by Backyard Kids. In addition, 12 were sold in Canada. These products pose a strangulation and asphyxia hazard and a risk of serious injury or death to young children who are climbing on the counter or crawling through the opening at the back of the play kitchens. Children's clothing can get caught on the hooks used to hold toy kitchen accessories, such as play pots and pans.

In February 2023 in Oregon, a 23-month-old child was asphyxiated after his shirt got caught on one of the hooks while climbing and crawling through the opening at the back of the play kitchen where the toy kitchen accessories are held. The child was unable to rescue himself and died from strangulation and asphyxia. KidKraft, Inc. filed for bankruptcy in May 2024. Backyard Kids has agreed to a provide free replacement hooks to all consumers with affected units as a part of this recall. The Farm to Table play kitchen is designed for pretend play and is intended for children 3 years or older. The play kitchen is primarily black and light gray with woodlike countertops and measures about 44 inches (length) x 13 ¾ inches (width) x 43 inches (height). The model number 53411 is on a sticker on the back of the play kitchen.

The play kitchens were sold online at KidKraft.com, Amazon.com and Walmart.com from 2018 through July 2025 for between \$120 and \$270.

Consumers should immediately stop using the play kitchens, remove the original hooks, and contact Backyard Kids for free replacement hooks.

They were sold in white, gray and black. The gates measure about 34 inches high with a retractable width of up to 140 inches and have an iron frame. "Retractable Safety Gate" and the model number are printed on a white label on the side post of the gate. LIVACTI appears on the product packaging.

**REMEDY**: Consumers should stop using the recalled gates immediately and contact Qeyan and Yanyanny for instructions on how to receive a full refund.
